

General Terms and Conditions Governing the Online Trading Contest March/April 2025

These General Terms and Conditions apply to the Online Trading Contest March/April 2025 (the "Contest") organised by Banque Cantonale de Genève (the "Bank"). The Contest consists of offering various vouchers (the "Rewards") to participants drawn at random (the "Winners") by the Bank. By participating in the Contest, the client accepts the General Terms and Conditions set out below.

General Terms and Conditions governing the Contest

1. The Contest is valid only from 01.03.2025 to 30.04.2025 (the "Contest Period").
2. The Contest is exclusively reserved for individual clients of the Bank who are of legal age and have an 1816 account and an 1816 custody account during the Contest Period. It does not apply to other services offered by the Bank. A client who opens an 1816 account and an 1816 custody account during the Contest Period is also considered a participant.
3. The Rewards will be awarded to the Winners provided that all of the following requirements are met:
 - a. The participant must be of legal age on 01.03.2025;
 - b. The orders taken into account for the draw must be entered via the Online portal (Netbanking) or via the BCGE Mobile Netbanking app and executed on the 1816 online trading platform during the Contest Period, no restrictions regarding the orders apply;
 - c. The Winners must be drawn at random from among all participants at the end of the Contest Period.
4. A draw will be held at the end of the Contest Period. To be considered eligible, orders must have been entered and executed between 1 March and 30 April 2025, regardless of the amount of the orders concerned. The Bank will contact the Winners to provide them with the following Rewards:
 - a. By drawing lots among the 20 most active participants in terms of the number of orders entered and executed during the Contest Period, 5 vouchers of CHF 200 to be credited to an 1816 account (1 voucher per Winner);
 - b. By drawing lots among the next 100 most active participants in terms of the number of orders entered and executed during the Contest Period:
 - I. 10 vouchers of CHF 120 to be used at the *Boutique des Grenat* (1 voucher per Winner);
 - II. 10 vouchers of CHF 90 for SwatchPAY! (1 voucher per Winner);
 - c. By drawing lots among the remaining participants, 50 vouchers worth CHF 20 in brokerage fees (1 voucher per Winner, reimbursement made on the next transactions made on the 1816 online trading platform, to be used outside the Contest Period and before 30.06.2025).
5. The Rewards may involve custody fees which will be borne by the participants.
6. The Terms and Conditions of Use for BCGE Netbanking, the Terms and Conditions of Use for 1816 online trading and the Bank's General Terms and Conditions are also applicable. The Bank reserves the right to modify, extend, shorten or cancel the Contest at its sole discretion, at any time, without prior notice and without liability on its part.
7. Any violation of these General Terms and Conditions by a participant will result in their ineligibility for the Contest. The Bank reserves the right to exclude, at any time, without justification or prior notice, any participant whose behaviour is not in line with the spirit of the Contest.
8. The Contest and these General Terms and Conditions are governed by Swiss substantive law. The place of performance and jurisdiction is Geneva, Switzerland.
